**FDA infrastructure** – Given shifting dynamics of City priorities and resulting changes in the neighborhood, over the next few months the Board hopes to address how we better align FDA infrastructure with neighborhood and resident needs.

#### TREASURER'S REPORT

The FDA's finances remain stable. Work will soon begin on the FY 2022 budget.

### **COMMITTEE REPORTS**

**Programs and Events:** Focus on the Holiday House Tour starts in August. Tim will reach out to 2020 home volunteers as we begin the planning and leadership process. Also, on August 3 FDA will host National Night Out in the Fan. Christy invites participation by all Board members who are in town.

**Code Enforcement and Zoning:** The committee is restructuring to support significantly increased code and zoning activity. It will expand to about 11 people and is currently identifying new members. Several current zoning and code issues are of note: 1) The Shenandoah SUP has been withdrawn and there are discussions about future use of the building; 2) The City has multiple initiatives in play that are important to the Fan including Pulse rezoning, a proposed

accessory dwelling unit ordinance and a short term rental ordinance. We continue to watch new developments related to proposed revisions in no parking restrictions.

**Membership.** FDA is currently reaching out to members who are delinquent in renewing dues and will update the FDA membership roster

With a note that there will be no July meeting and there being no further business, the meeting was adjourned.
