- II. Guest Presentations and Guest Reports
 - Lisa Mathews-Ailsworth, VCU Off Campus Student Services Coordinator New coordinator role on campus designed to extend assistance to our students on such issues as landlord/tenant agreements and leases and other such challenges.
 - Alyse Marhsall-Auernheimer, Building a Better RPD
 The objective is to raise \$1m in cash and in-kind gifts to help address and solve problems with our schools in such basic challenges as lighting and landscaping in all 47 Richmond Schools. Our plan is to have a team leader in every school to help identify and focus our efforts for that very location. Intend to utilize the Richmond Education Foundation to collect and direct monies we raise at an approximately administrative cost of 5%

 Overall crime numbers are down, we have had recent arrests on vehicle theft crimes and currently focusing on a robbery in the 2000 block of West Grace Street.
 Continue to ask that your neighbors please call RPD when/if they see anything suspicious. Larceny crimes typically increase in warm weather with more people out and staying out later. Vehicle crime continues to be of concern to us and well over 50% of such crimes involve unlocked vehicles. We are currently limited in manpower for bike patrols just one such team in the District.
